

RESOLUTION NO. 2017-055

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SAN BUENAVENTURA , CALIFORNIA,
CONFIRMING THE EXISTENCE OF A LOCAL
EMERGENCY**

WHEREAS, Chapter 2.370 of the San Buenaventura Municipal Code empowers the Director of Disaster Services to proclaim the existence or threatened existence of a local emergency when the City is affected or likely to be affected by a public calamity and the City Council is not in session, subject to ratification by the City Council; and,

WHEREAS, Conditions of extreme peril to the safety of persons and property have arisen within this City by a fire and wind event, i.e., the Thomas fire, commencing on or about 10:00 pm on the fourth day of December 2017 at which time the City Council of the City of San Buenaventura was not in session; and,

WHEREAS, Said City Council does hereby find that the aforesaid conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency; and,

WHEREAS, The Director of Disaster Services did proclaim the existence of a local emergency within said City on the 4th day of December 2017 at 10:05 pm.

NOW, THEREFORE, the City Council of the City of San Buenaventura does hereby resolve, find, determine, and order as follows:

Section 1: That a state of local emergency shall be deemed to continue to exist until its termination is proclaimed by the City Council of the City of San Buenaventura, State of California.

Section 2: That the City Clerk shall cause this state of local emergency to be scheduled for re-confirmation at least every 21 days until terminated by this City Council.


