

RESOLUTION NO. 2018-047

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SAN BUENAVENTURA, CALIFORNIA,
RE-CONFIRMING THE EXISTENCE OF A LOCAL
EMERGENCY AND A LOCAL PUBLIC HEALTH
EMERGENCY**

WHEREAS, Chapter 2.370 of the San Buenaventura Municipal Code empowers the Director of Disaster Services to proclaim the existence or threatened existence of a local emergency when the City is affected or likely to be affected by a public calamity and the City Council is not in session, subject to ratification by the City Council; and,

WHEREAS, Conditions of extreme peril to the safety of persons and property have arisen within this City by a fire and wind event, i.e., the Thomas fire, commencing on or about 10:00 pm on the fourth day of December 2017 at which time the City Council of the City of San Buenaventura was not in session; and,

WHEREAS, Said City Council does hereby find that the aforesaid conditions of extreme peril did warrant and necessitate the proclamation of the existence of a local emergency; and,

WHEREAS, The Director of Disaster Services did proclaim the existence of a local emergency within said City on the 4th day of December 2017 at 10:05 pm; and,

WHEREAS, The City Council confirmed the existence of a local emergency at its regular meeting of December 11, 2017 by adopting Resolution No 2017-055; and,

WHEREAS, The Public Health Officer for the County of Ventura declared a local public health emergency; and,

WHEREAS, The Ventura County Public Health Officer serves as the Health Officer for the City of San Buenaventura; and,

WHEREAS, The City Council confirmed the local public health emergency at its regular meeting of December 11, 2017 by adopting Resolution No. 2017-056; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of December 18, 2017 by adopting Resolution No. 2017-057; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of January 8, 2018 by adopting Resolution No. 2018-001; and

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of January 22, 2018 by adopting Resolution No. 2018-002; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of February 12, 2018 by adopting Resolution No. 2018-005; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of February 26, 2018 by adopting Resolution No. 2018-006; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of March 19, 2018 by adopting Resolution No. 2018-008; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of April 9, 2018 by adopting Resolution No. 2018-017; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of April 23, 2018 by adopting Resolution No. 2018-019; and,

WHEREAS, The City Council confirmed the local emergency as well as the local public health emergency at its meeting of May 14, 2018 by adopting Resolution No. 2018-028; and,

WHEREAS, the City Council confirmed the local emergency as well as the local public health emergency at its meeting of June 4, 2018 by adopting Resolution No. 2018-031; and,

WHEREAS, the City Council confirmed the local emergency as well as the local public health emergency at its meeting of June 18, 2018 by adopting Resolution No. 2018-037; and,

WHEREAS, the City Council confirmed the local emergency as well as the local public health emergency at its meeting of July 9, 2018 by adopting Resolution No. 2018-043; and,

WHEREAS, the City Council confirmed the local emergency as well as the local public health emergency at its meeting of July 23, 2018 by adopting Resolution No. 2018-46; and,

WHEREAS, The State Emergency Services Act requires that the existence of a local emergency be re-confirmed at least every twenty-one days or the existence of a local emergency shall terminate.

NOW, THEREFORE, the City Council of the City of San Buenaventura does hereby resolve, find, determine, and order as follows:

Section 1: That a state of local emergency shall be deemed to continue to exist and is hereby re-confirmed until its termination is proclaimed by the City Council of the City of San Buenaventura, State of California.

Section 2. That a local public health emergency shall be deemed to continue to exist and is hereby re-confirmed until its termination is proclaimed by the City Council of the City of San Buenaventura, State of California.

Section 3: That the City Clerk shall cause this state of local emergency and local public health emergency to be scheduled for re-confirmation at least every 21 days until terminated by this City Council.




