RESOLUTION NO. 2023-032

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN BUENAVENTURA, CALIFORNIA, EXPANDING THE NUMBER OF CARD TABLES AUTHORIZED TO OPERATE IN ITS JURISDICTION BY 100, PURSUANT TO SAN BUENAVENTURA MUNICIPAL CODE SECTION 10.750.430(A)

WHEREAS, The City of San Buenaventura currently has authorized 22 card tables to operate within its jurisdiction; and,

WHEREAS, San Buenaventura Municipal Code section 10.750.430(A) authorizes the City Council to approve by resolution a greater number of card room tables to operate within the City's jurisdiction; and,

WHEREAS, California State Law currently does not prohibit a municipality from expanding its number of authorized card tables.

NOW, THEREFORE, the City Council of the City of San Buenaventura does hereby resolve, find, determine and order as follows:

Section 1 The City of San Buenaventura shall increase its number of card tables authorized to operate within its jurisdiction by 100, for a new total of 122 authorized card tables.

Section 2: San Buenaventura Municipal Code Section 10.750.430 is amended to read as follows:

Sec. 10.750.430 – Number of tables and games.

- A. A total of 122 card tables, or such greater number of card tables as permitted by applicable state or city law and which has first been approved by resolution of the City Council, may be operated within the city's jurisdiction. Any such approval resolution shall not become effective until the thirty-first day following its approval and shall be subject to referendum.
- B. No more than one game will be played at any one table at the same time in any card room.
- C. The maximum number of tables that may be operated by an annexed card room is 122 tables or such greater number as permitted by applicable state or city law and which has first been approved by resolution of the city council. Any such approval resolution shall not become effective until the thirty-first day following its approval and shall be subject to referendum.

Section 3: CEQA Findings.

EXEMPTION FROM CALIFORNIA ENVIRONMENTAL QUALITY ACT. The City Council further finds that this Ordinance is exempt under Section 15061 (b)3 of the of Title 14 of the California Code of Regulations (the "State CEQA Guidelines") in that the enactment of this Ordinance merely implements an administrative process that will not foreseeably result in construction activities or other physical activities, either directly or indirectly. Accordingly, it can be seen with certainty that the enactment of this Resolution does not have the potential to result in significant effects on the environment.
